SUBJECT:

"Ellipsis is anaphoric in nature, as it depends on an antecedent in the context for recovery of meaning. The relationship between the ellipsis and its antecedent is not unconstrained. Rather it is subject to a parallelism requirement, typically stated in terms of a formal identity constraint. [...]

The nature of the identity constraint and its precise formulation has been extensively debated in linguistics. Much of the debate has focused on the question of whether the identity requirement is defined over syntactic structures, or over semantic representations. [...]

The *syntactic account* claims that the representation of an elided phrase is recovered under some form of structural identity. The *semantic account* claims that the recovery process involves identity of meaning."
